Instructions for filling out the Official Candidate Petition for Jay SFMayor Candidacy

By now you have downloaded the .pdf document onto your computer. If you are viewing this document in your browser, left click the link and select save as... to download it. You will need to print the first two pages of this document, and if you can, please print it double sided. Although the government told me they want the copies to be double sided, I'm sure legally we can still turn them in as two one-sided documents, but only if they are stapled together. Do try to print it double sided though as it saves paper and is good for the environment.

So print the first two pages, double-sided if you can, or you can staple the two pages afterwards You will need to fill out both sides of the petition, and it will need to be perfectly correct or your signature will not be counted, so I am going to talk you through it step by step. It's pretty simple though, just make sure to complete all of these steps.

On the first page you can skip the two boxes on the top, those are for election officials.

Next you can print and sign your name, and write the address where you are REGESTERD to vote. You must be registered to vote in the County and City of San Francisco to fill out this form. Anyone who lives in another county or city, is not registered, or is considered to young, can support me online or by filling out my informal petition.

That's it for the first page... not too bad. Now for the back-side.

As you can see, up to 10 people can sign this petition. You must print or copy more petitions to collect more signatures.

Since you have printed this petition, you have become the "Circulator" of the petition and therefore you must sign the Affidavit of Circulator on the back of the petition. If you don't want to go to the trouble to fill this out, you can sill send it back to me, but your signature might not count, and have an even lesser chance if there is more than one signature on the petition.

The first blank after "I," is simply filled in with your name. The next blank after "in-lieu of filing fee of" is filled in with my name. Jay Blas Jacob Cabrera. The next blank after "My residence address is" is filled in with the address you are registered at.
·
The next blanks after "signatures were obtained between, 2011 and, 2011" is filled in with the month and day of when the first signer signed the petition and the last signer. If only one person signed it, or everyone signed it of the same day, then these could be the same date. What is important is that the date is after June 3 rd , 2011 and before July 28 th 2011.
The next two blanks after "true and correct Executed on:" is where you certify the signatures on the petition by writing the date, the location where you signed it, and signing as the circulator of this petition. For location San Francisco should be good enough, but you can put your neighborhood if you want. Next you simply Mail it to me before July 25th to:
